- Been a donor to Food Banks Canada for a minimum of 3 consecutive years and demonstrated growth of partnership and engagement over that time
- Identified Hunger (or food banks) as a cause of choice within the organization’s CSR or overall philanthropic guidelines
- Made an impact on hunger and/or food banking in Canada
